Whereas: Purchase of the 13,000 acre Paul Downs Estate in Sharp County, Arkansas has not been finalized, and

Whereas: Management inventory and planning has not been completed,

Therefore Be It Declared that a temporary emergency exists and that it shall be unlawful to hunt or possess any killing device on the 13,000 acre Paul Downs Estate. This temporary emergency closure will be in effect until 1 July 77.

PENALTY: \$100.00 to \$500.00.
