AIDING, ACCOMPANYING, OR ABETTING A VIOLATOR. Unlawful for any person to aid, accompany, or abet another in taking or attempting to take in any illegal manner any wild animal, wild bird, fish or frogs or any protected species.

It is further provided that it shall be unlawful for any person to knowingly aid, accompany or abet another in illegal possession, illegal transport or illegal sale of any species of wild animal, wild bird, fish or frogs. Penalty for so doing shall be the same as that applicable to a principal in the violation.

AIDING, ACCOMPANYING, OR ABETTING A VIOLATOR. Unlawful for any person to aid, accompany, or abet another in taking or attempting to take in any illegal manner any wild animal, wild bird, fish or frogs or any protected species.

It is further provided that it shall be unlawful for any person to knowingly aid, accompany or abet another in illegal possession, illegal transport or illegal sale of any species of wild animal, wild bird, fish or frogs. Penalty for so doing shall be the same as that applicable to a principal in the violation.
